An Introduction to Research and Evidence Based Practice

Joanne is a Registered Pharmacy Technician with over 15 years' experience in hospital pharmacy, predominantly in mental health. After 7 years working as Senior Pharmacy Technician for North West Borough Healthcare and having responsibility over the pharmacy clinical trials service, she then moved into clinical research. In 2016, Joanne was awarded an Integrated Clinical Academic studentship by the National Institute for Health research, and is currently working part time as a researcher and study coordinator whilst studying for a Masters in Clinical Research at the University of Manchester.

She spent the last few years working as a medicines management technician (with a sneaky 8 months holiday travelling). Annabel was asked if she would be interested in a new role working in the community. This involves working closely with the clozapine clinics, GPs and Intensive Community Services. This has been a welcome challenge and she has enjoyed the freedom this role has given to pilot new schemes, ideas, take up new training opportunities and meet a wide range of people from staff to the patients.

Emma started working in pharmacy in 2010 as a counter assistant. After getting a feel for the environment she pursued training in community pharmacy.
